Given the editorial policy of this journal, we have strived hard in attracting articles that meet the purposes of diversity of topics covered, as well as the origins of the contributions and methodologies used in the scientific productions. It is not always easy to reconcile these three purposes.

The practice of publishing an academic journal is a noble, but challenging activity. In this issue we are pleased to start the publications with the article "indicators of scientific production on lessons learned in project management." With this scenario, we hope to provide you with one more contribution of the Journal of Management & Technology.
