In this issue, besides the scientific production in accordance with its purpose and praxis, it is presented to the reader, in a pioneering initiative, a Technical Report addressing the topic of "Knowledge management in a research development agency: proposal of an applied model " and a *Pensata* that contextualizes and reflects upon the "The Professional Master Program in Business Administration from the Pedro Leopoldo Foundation": pioneering and new frontiers".

In this edition, the articles submitted for consideration by the academic community can be divided into two segments. The first covers the themes of Governance, Social Management and Human Resources, with the following papers: "The time of a CEO term in office and business performance: a comparative study of family owned and non-family owned Brazilian businesses"; "A model of port governance from the perspective of its managers: a study in the Port of Santos"; "Analysis of the structure and functioning of boards of directors with a view to: (de) constructing the rationalities of the discourses of the actors"; "Qualitative research in social management: an analysis of knowledge production in case studies"; "Values in the work of managers of health organizations: survey in a federal public hospital"; and "Subjectivity and identity of the front managers to new roles required in the current organizational context."

In the second segment themes of Project Management, Innovation and Marketing Services are covered. The following papers are presented: "Success factors of implementing a PMO: a case in Public Administration";"Technological capacity in companies that are part of the system of software innovation from Curitiba: a multiple case study";and "Dimensions of consumer awareness on e-waste recycling process (E-WASTE)."

Looking forward to receiving contributions from researchers in the various areas of management that are aligned with the purposes of this journal, and with our commitment for a rapid evaluation of articles by our referees, I would like to wish our readers a good reading and great reflections.
