Dear Reader,

One of the many terms that have been assumed and used in the scientific academia has been the "publisch or perish". Although it originates in the academic world of the United States, its approach has been intensifying in Brazil.

The concept refers to and induces the compulsion for publications, usually intensive and uncreative, often on repetitive and at most incremental to the literary knowledge. Rare, therefore, are effectively innovative productions, in epistemic, conceptual, and morphological logics.

Institutional pressures for publications certainly lead to this situation, also known pejoratively as "productivism." In this context, increasingly, quantification metrics of scientific production appear, which become more sophisticated in concepts and technologies, giving rise to structures and formats, such as scientometry, bibliometry, infometrics, webmetry and altimetry, among others.

These metrics of scientific and technical production have certainly led, both to the refinement of the content specification and methods of approach, and, as a consequence, to the strict framing of measurement parameters established by the curriculum demonstration bases of authors, being the most well-known, the Lattes platform. Effectively, the dynamics of productions, and their respective launch criteria, have implied the necessary updating of the bases, approaching them to the ORCID structure. This situation reveals a great community in action, provoking the effervescence of the researchers' activity. In addition, it also demonstrates the need for guidance in immersion in topics that are effectively innovative, in the epistemological, morphological and methodological logics, in order to reveal elements of the reality of societies, organizations and people, especially in our case, Brazil.

It is in this context that the Journal of Management & Technology is inserted. The breadth of its terms, "management" and "technology" demonstrates its purposes and processes, in the sense of being a journal oriented to the Science of Administration and related areas, however in a plural approach. In this sense, it has been receiving submissions and publishing contributions from themes, researchers and diverse institutions, consolidating itself as a rich source of knowledge in evolution, that is, in a state of organization and systematization.

For this purpose, the Journal of Management & Technology has been discovered by foreign researchers, who submit aggregating contributions to the various topics that have already been published, providing greater epistemic-theoretical-methodological enrichment of this journal.
